



Swimming Pools

The Town of New Tecumseth Zoning By-law 2014-126 includes the following provisions:

Swimming pools are permitted in the following zones:

“UR1”, “UR2”, “UR3”, “UR4”, “HR”, “ER”, “EP”, “I”, and in Agricultural Zones

- They may be located in any yard other than a required front or exterior side yard
- In an Agricultural or Residential Zone, the minimum setback for a pool from the side or rear lot line shall be 1.2 m
- In an Environmental Protection or Institutional Zone, the minimum setback for a pool from the side or rear lot line shall be 9.0 m
- If an above-ground pool is surrounded by a deck, the required setback, as specified above, shall be measured from the outside edge of the deck
- Setbacks for swimming pools, with the exception of those specified in section 4 of the by-law, shall be measured from the inside edge of the swimming pool

- All swimming pools shall be required to be fully enclosed by a fence in accordance with the Town’s Fence By-law
- Any swimming pool located in association with an apartment building shall have a minimum setback of 9.0 m from said apartment building
- In-ground swimming pools and swimming pools constructed above grade, that are not enclosed by a building or structure, shall not be included in the calculation of lot coverage.

A Municipal Permit is required for the construction of a pool and the fence surrounding it (See page 2). Permit drawings must show dimensions for required setbacks. Permission for a minor variance from the provisions of the Zoning By-law may be requested through an application to the Committee of Adjustment.

Municipal Permit Application (Pool Enclosure Permit)

The Town of New Tecumseth Engineering Department regulates and reviews grading around proposed pools.

- The intent of plans submitted for review to the Engineering Department is to show that grading at property lines will be matches and that boundary drainage will not be blocked.
- **A scaled plot plan can be obtained from the Town's Engineering Department for most urban lots** upon which the pool location is to be drawn. The complete plan shall be submitted as part of the application for the permit.
- In addition to the pool location, the plan shall show all features associated with the pool which will be installed, such as; decks, patios, sheds, walkways, etc. drawn in appropriate scale.
- Any proposed changes to the existing boundary grading resulting from the installation of the pool, on grade decks, patios or walks or the addition of any retaining walls may require a grading plan to be provided designed by a qualified professional or a professional engineer.

Application Requirements:

- **Municipal Permit application form**
- **Scaled grading plan (obtain from Town Engineering Dept.)**
 - Description of the pool (in-ground, above-ground, on ground)
 - Location of pool, fence, and any impervious decking or walks around the pool. All of these items must be dimensioned for their size and in relation to the property lines.
 - Description of the construction of all fences and gates.
 - Location of all existing grades, swales and land drainage as a result of the proposed construction.
- **The fee for a municipal pool enclosure permit is \$55.00 plus a security deposit of \$200.00 that is refundable after the final inspection.**
